John Dunkin opened the forum at 7:00 p.m. with a presentation from Courtney Sanford, w/American Red Cross (Red Cross). Courtney explained the Red Cross offers classes in First Aid/CPR/AED. SMCUOA could arrange for the Red Cross class to be offered on site. There is a fee for the class. The class is offered at the Red Cross for around \$100.00. Courtney is working with John Dunkin to offer a discounted fee of \$70-\$90, depending on class size. Once approved, the certification is good for 2 years. Courtney brought a (Zoll) AED Unit with her. The AED was demonstrated. The AED is used for a person unconscious, on the floor. While you should always call 911 immediately, the AED “talks” you through the application of the unit. Batteries and pads need to be replaced every 5 years. If the pads are used, they must then be replaced.

The Board is considering the purchase of the AED Unit. No decision has been made.
